

Infosys Technologies to Announce First Quarter Results on July 11, 2007

Bangalore, India and Fremont, California – June 28, 2007: Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its First Quarter ended June 30, 2007 on Wednesday, July 11, 2007, Indian Standard Time (IST) (on the night of Tuesday, July 10, 2007, US Eastern Time (ET)).
