

## Infosys Technologies to Announce Second Quarter Results on October 15, 2010

**Bangalore, India and Fremont, California – September 29, 2010:** Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its second quarter ending September 30, 2010 on Friday, October 15, 2010, Indian Standard Time (IST) (on the night of Thursday, October 14, 2010, US Eastern Time (ET)).
