

Infosys to Announce Third Quarter Results on January 12, 2018

Bengaluru, India – January 5, 2018: Infosys Limited (NSE, BSE, NYSE: INFY), a global leader in consulting, technology, outsourcing and next-generation services, will announce the results for its third quarter ended December 31, 2017 on Friday, January 12, 2018 around 3:45 p.m. Indian Standard Time (IST) (5:15 a.m. US ET; 2:15 a.m. PST; 10:15 a.m. London time; 6:15 p.m. Singapore/Hong Kong time).
