Sub: Update on McCamish Cyber Incident

In continuation to our **statement** dated March 14, 2025, we would like to update that on August 5, 2025, Infosys McCamish Systems ("**IMS**"), a subsidiary of Infosys BPM limited (a wholly owned subsidiary of Infosys limited) and the State of Oregon (United States of America) Attorney's General Office entered into an Assurance of Voluntary Compliance ("**AVC**").

The Oregon Attorney's General Office expressed concerns that IMS may have violated the Oregon Consumer Information Protection Act, and the Oregon Unlawful Trade Practices Act with respect to a 2023 data breach.

IMS has entered into an Assurance of Voluntary Compliance to resolve this matter without any further action. The AVC specifically acknowledges that this is not an admission or finding that IMS violated the Acts as listed above, and that IMS does not admit any of the factual assertions contained in the AVC.

Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible As part of the Assurance of Voluntary Compliance, IMS will pay a sum of \$225,000 dollars to the Oregon Attorney General's Office, with the full amount due within thirty business days of IMS' execution of the Assurance of Voluntary Compliance and its receipt of payment instructions from the Oregon Attorney General's Office.
