I, Parameshwar G. In accordance with the Notice of the Postal Ballot dated January 03, 2018, dispatched to the shareholders by prescribed modes during January 18, 2018 to January 21, 2018 and the 'Advertisement' published pursuant to Rule 22(3) of the Companies (Management and Administration) Rules, 2014 published on January 22, 2018, the voting commenced on January 22, 2018 (at 9:00 hours) and ended on

February 20, 2018 (at 17:00 hours) for physical ballots and as well as for e-voting. The e-voting facility was provided by National Securities Depository Limited (NSDL). The votes were unblocked at around 17:05 hours on February 20, 2018 and the e-voting summary statement was downloaded from e-voting website of National Securities Depository Limited (NSDL) (https://www.evoting.nsdl.com).

- 3. The Equity Shareholders holding shares as on January 15, 2018, "cut off date", were entitled to vote on the resolutions stated in the Notice of the Postal Ballot.
- 4. The ballot papers received were scrutinized. The ballot papers received were reconciled with the records maintained by the Company / R&TA and the authorizations / power of attorney etc. lodged thereof.
