

Infosys Donates Breath Alcohol Analyzers to Bangalore City Traffic Police

Bangalore, India – June 29, 2000 – Infosys Technologies Limited (NASDAQ: INFY), a leading IT solutions provider, today donated 22 Breath Alcohol Analyzers to the Bangalore City Traffic Police. Mr. N.
