

Infosys Technologies to Announce Second Quarter Results on October 10

Bangalore, India and Fremont, California, USA -- October 5, 2000 -- Infosys Technologies Limited (NASDAQ: INFY), a leading software consulting firm, will announce results for its second quarter and half-year ending September 30, 2000 on Tuesday, October 10, 2000, Indian Standard Time (IST) (on the night of Monday, October 9, 2000, US Eastern Time (ET)). The results will also be available on the Infosys web-site at www.infy.com.

Following the release, Infosys Chairman and CEO N. R. Narayana Murthy, Managing Director, President and COO Nandan M. Nilekani, and Director - Finance & Administration and CFO T. V.
