

Infosys Technologies to Announce Fourth Quarter Results on April 11

Bangalore, India and Fremont, CA -- April 7, 2000 -- Infosys Technologies Limited (NASDAQ: INFY), a leading software consulting firm, will announce results for the quarter and year ending March 31, 2000 on Tuesday, April 11, 2000, Indian Standard Time (on the night of Monday, April 10, 2000, US Eastern Time (ET)).
