

Infosys Technologies to Announce Third Quarter Results on January 10, 2003



Bangalore, India and Fremont, California. – January 06, 2003 – Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its Third Quarter ended December 31, 2002 on Friday, January 10, 2003, Indian Standard Time (IST) (on the night of Thursday, January 9, 2003, US Eastern Time (ET)).
