

## Infosys Technologies to Announce First Quarter Results on July 12, 2005

Bangalore, India and Fremont, California – July 5, 2005 – Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its First Quarter ended June 30, 2005 on Tuesday, July 12, 2005, Indian Standard Time (IST) (on the night of Monday, July 11, 2005, US Eastern Time (ET)).
