

Infosys Technologies to Announce Third Quarter Results on January 11, 2000

December 28, 1999 -- Bangalore, India and Fremont, CA -- Infosys Technologies (NASDAQ: INFY), a leading software consulting firm, will announce results for the quarter ending December 31, 1999 on Tuesday, January 11, 2000 (on the night of Monday, January 10, 2000, Eastern Standard Time (EST)).
