

## Infosys Technologies to Announce Second Quarter Results on October 8

**Bangalore, India -- October 1, 1999** -- Infosys Technologies (NASDAQ: INFY), a leading software consulting firm, will announce results for the quarter ending September 30, 1999 on Friday, October 8, 1999 (on the night of Thursday, October 7, 1999, Eastern Standard Time).
