

Infosys Technologies to Announce Second Quarter Results on October 11, 2006

Bangalore, India and Fremont, California – October 06, 2006: Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its Second Quarter ended September 30, 2006 on Wednesday, October 11, 2006, Indian Standard Time (IST) (on the night of Tuesday, October 10, 2006, US Eastern Time (ET)).
