

Canadian Pacific and Infosys Sign Multi-Year "Modular Global Sourcing" Agreement for I.T. Services and Support

Toronto, Canada, August 2, 2007 - Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, today announced a multi-year agreement with Canadian Pacific (CP) to provide Modular Global Sourcing services for its information technology organization, Business and Information Technology Services (BITS). Infosys will help CP improve its I.T. delivery capabilities through BITS' strategic "Bestshoring" initiative.

Canadian Pacific, headquartered in Calgary, Alberta, and its subsidiaries operate a 13,500-mile transcontinental railway that spans Canada, and the Northeast and Midwest regions of the United States. CP also provides logistics, supply chain expertise, and rail and intermodal transportation services.

"We look forward to working with BITS to develop an I.T. support structure that delivers the solutions and services that meet the ever-demanding requirements of railway transportation."
