

# Infosys Technologies to Announce Fourth Quarter and Annual Results on April 13, 2007

Bangalore, India and Fremont, California – March 28, 2007 – Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its Fourth Quarter and Year ended March 31, 2007 on Friday, April 13, 2007, Indian Standard Time (IST) (on the night of Thursday, April 12, 2007, US Eastern Time (ET)).
