

# Infosys Technologies to Announce Second Quarter Results on October 10, 2008

Bangalore, India and Fremont, California – September 25, 2008 – Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its Second Quarter ending September 30, 2008 on Friday, October 10, 2008, Indian Standard Time (IST) (on the night of Thursday, October 09, 2008, US Eastern Time (ET)).
