

Infosys Technologies to Announce Fourth Quarter and Annual Results on April 15, 2008

Bangalore, India and Fremont, California – March 26, 2008 – Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its Fourth Quarter and Year ended March 31, 2008 on Tuesday, April 15, 2008, Indian Standard Time (IST) (on the night of Monday, April 14, 2008, US Eastern Time (ET)).
