## 1. General

### 1.1 Scope

#### 1.1.1 Geographical scope

The BCR apply to Infosys Limited and all of its branches, entities and subsidiaries worldwide (together “**INFOSYS GROUP**”). INFOSYS GROUP, as well as all employees within INFOSYS GROUP must comply with the BCR.

The data importers and exporters in the EEA and outside the EEA are set out in [Appendix 1](#).

#### 1.1.2 Material scope

The BCR apply to all personal data processed by INFOSYS GROUP for processor activities that are submitted to EEA law, including Switzerland, and transferred directly or indirectly between INFOSYS GROUP members acting as processors on behalf of controllers who are not members of INFOSYS GROUP.

#### 1.1.3 Commitment to comply with BCR

INFOSYS GROUP and its employees must comply with its obligations under these BCR and EEA data protection laws whenever INFOSYS GROUP is processing personal data. Where local legislation, in particular EU legislation, requires a higher standard of protection for personal data, it will take precedence over the BCR. In any event, data shall be processed in accordance with EEA data protection law, in particular with the data protection principles laid out in Section 2.1, and the relevant local legislation.

The BCR shall be made binding towards the controller through a specific reference to it in the service agreement which shall comply with the legal requirements on a data processor in accordance with the GDPR. The controller shall have the right to enforce the BCR against any member of INFOSYS GROUP for breaches they caused, and, moreover, against Infosys Germany Holding GmbH in case of a breach of the BCR or of the service agreement by INFOSYS GROUP members established outside of the EEA or of a breach of the written agreement referred under Section 2.1, by any external subprocessor established outside of the EEA.

## 2. Data protection safeguards

### 2.1 Data protection principles

The GDPR requires that INFOSYS GROUP as a processor processes personal data only according to documented instructions of the controller who shall comply with the following data protection principles:

- only processes personal data for fair and lawful purposes;
- in accordance with additional restrictions for special categories of personal data;
- is transparent with data subjects and tells them how it will use their information;
- informs the data subject about his/her right to lodge a complaint with the Competent Supervisory Authority at the place of his/her habitual residence, place of work or place of alleged infringement or before the competent court of the respective EEA Member State – at the data subject’s choice at the data exporters’ location or at the place of data subject’s habitual residence;
- meets data quality obligations and holds personal data for a limited retention period;

- as a general rule minimizes the amount of personal data it collects and processes, and chooses and structures its processing systems accordingly;
- as a general rule grants its staff access to personal data on a “need to know” basis only;
- implements appropriate security obligations to protect personal data;
- upholds individuals’ rights to access and correct their information and, to prevent certain types of processing;
- only transfer personal data to other jurisdictions than their own when protections for personal data are in place as required by local law (e.g. European Operations only transfer personal data out of the EEA and Switzerland when protections for personal data are in place such as the standard contractual clauses provided by the EU Commission); and
- every member of INFOSYS GROUP including its employees respects the instructions from the controller regarding the data processing and the security and confidentiality measures as provided in the service agreement.

## **2.2 Restriction on transfers and onward transfers to internal and external subprocessors**

INFOSYS GROUP may transfer data to another member of INFOSYS GROUP as a subprocessor only with the prior informed specific or general written authorization of the controller. The service agreement will specify if a general prior authorization given at the beginning of the service would be sufficient or if a specific authorization will be required for each new subprocessor. If a general authorization is given, the controller should be informed by INFOSYS GROUP of any intended changes concerning the addition or replacement of a subprocessor in such a timely fashion that the controller has the possibility to object to the change or to terminate the contract before the data are communicated to the new subprocessor.

Personal data may be sub-processed by non-members of INFOSYS GROUP only with the prior informed specific or general written authorization of the controller. If a general authorization is given, the controller should be informed by INFOSYS GROUP of any intended changes concerning the addition or replacement of subprocessors in such a timely fashion that the controller has the possibility to object to the change or to terminate the contract before the data are communicated to the new subprocessor.

Where any member of INFOSYS GROUP subcontracts its obligations under the service agreement, with the authorization of the controller, it shall do so only by way of a contract or other legal act under EU law or EEA Member State law with the sub-processor which provides that adequate protection is provided as set out in the requirements under the GDPR in regard to data processing agreements, processing under the authority of the controller or processor, the security of processing, transfers on the basis of adequacy decisions and/or transfers subject to the appropriate safeguards (as applicable) and binding corporate rules and which ensures that the same data protection obligations as set out in the service agreement between the controller and the processor and including third party beneficiary rights for data subjects (including the possibility to lodge a complaint before the Competent Supervisory Authority and before the Courts), responsibility towards the controller, duties to cooperate with the Supervisory Authorities and the controller, and data protection safeguards are imposed on the subprocessor, in particular providing sufficient guarantees to implement appropriate technical and organization measures in such a manner that the processing will meet the requirements of the GDPR.

In case of subprocessing INFOSYS GROUP ensures that all external subprocessors within the EEA or in countries certified by the EU Commission as having an adequate level of protection shall be bound by a written agreement stipulating that the subprocessor shall act only on

instructions from the controller and shall be responsible regarding the implementation of adequate security and confidentiality measures.

INFOSYS GROUP will put in place EU Standard Contractual Clauses or other suitable agreements to regulate the transfers of data to external providers located outside the EEA or the countries that have been recognized by the EU Commission as ensuring an adequate level of protection.

European operations staff must seek the input of the Global DPO if an INFOSYS GROUP entity seeks to transfer personal data to a new supplier outside the EEA or if it seeks to transfer new categories of data to INFOSYS GROUP entities outside the EEA. The input of the Global DPO must include the information whether prior notification or authorisation of the transfer by the Competent Supervisory Authority is required.

## **2.3 Actions in case of national legislation preventing respect of BCR**

A member of INFOSYS GROUP

(i) will use the BCR as a tool for transfers only where they have assessed that the law and practices in the third country of destination applicable to the processing of the personal data by the INFOSYS GROUP member acting as data importer, including any requirements to disclose personal data or measures authorising access by public authorities, do not prevent it from fulfilling its obligations under these BCR.

This is based on the understanding that laws and practices that respect the essence of the fundamental rights and freedoms, and do not exceed what is necessary and proportionate in a democratic society to safeguard national security, defence, public security, the prevention, investigation, detection or prosecution of criminal offences, the protection of judicial independence and judicial proceedings, the prevention, investigation, detection and prosecution of breaches of ethics for regulated professions, the protection of the data subject or the rights and freedoms of others or the enforcement of civil law, are not in contradiction with the BCR.

The INFOSYS GROUP members, in assessing the laws and practices of the third country which may affect the respect of the commitments contained in the BCR, have taken due account of the following elements:

- The specific circumstances of the transfers or set of transfers, and of any envisaged onward transfers within the same third country or to another third country, including:
  - purposes for which the data are transferred and processed;
  - types of entities involved in the processing (the data importer and any further recipient of any onward transfer);
  - economic sector in which the transfer or set of transfers occur;
  - categories and format of the personal data transferred;
  - location of the processing, including storage; and
  - transmission channels used.
- The laws and practices of the third country of destination relevant in light of the circumstances of the transfer, including those requiring to disclose data to public authorities or authorising access by such authorities and those providing for access to these data during the transit

between the country of the data exporter and the country of the data importer, as well as the applicable limitations and safeguards.

- Any relevant contractual, technical or organisational safeguards put in place to supplement the safeguards under the BCR, including measures applied during the transmission and to the processing of the personal data in the country of destination.

The INFOSYS GROUP members are obliged to document such assessment and make such documentation available to the Competent Supervisory Authority on request.

- (ii) shall promptly notify the data exporter, Infosys Germany Holding GmbH and the Global DPO, where it has reasons to believe that the applicable or future legislation or a measure (such as a disclosure request) prevents INFOSYS GROUP from fulfilling the instructions received from the controller or its obligations under the BCR or service agreement, or has substantial effect on the guarantees provided by the provisions unless otherwise prohibited by a law enforcement authority. Upon verification of such notification, the INFOSYS GROUP member acting as data exporter, along with Infosys Germany Holding GmbH and the Global DPO and the relevant privacy officers, shall forward the notification to the controller and promptly identify supplementary measures (e.g. technical or organisational measures to ensure security and confidentiality) to be adopted by the INFOSYS GROUP member acting as data exporter and/or data importer, in order to enable them to fulfil their obligations under the BCR, if appropriate in consultation with the controller. The same applies if an INFOSYS GROUP member acting as data exporter has reasons to believe that an INFOSYS GROUP member acting as its data importer can no longer fulfil its obligations under this BCR.

The data exporter shall suspend the data transfer if it considers that no appropriate safeguards for such transfer can be ensured, or if instructed by the controller or the Competent Supervisory Authority to do so.

Any legally binding request for disclosure of the personal data by a law enforcement authority or a state security body shall be communicated to the controller unless otherwise prohibited, such as a prohibition under criminal law to preserve the confidentiality of a law enforcement investigation.

In addition, a member of the INFOSYS GROUP shall inform the Competent Supervisory Authority where any legal requirement it is subject to in a third country is likely to have a substantial adverse effect on guarantees provided by the BCR. This includes legally binding requests for disclosure of personal data by a law enforcement agency or a state security body. In such a case, the request for disclosure should be put on hold and the Supervisory Authority competent for the controller and the Competent Supervisory Authority for INFOSYS GROUP as a processor should be clearly informed about the request, including the data requested, the requesting body and the legal basis for the disclosure, unless otherwise prohibited by a law enforcement authority.

If in specific cases the suspension and/or notification are prohibited, the requested member of INFOSYS GROUP will use its best efforts to obtain the right to waive this prohibition in order to communicate as much information as it can and as soon as possible and be able to demonstrate that it did so. If, in the above cases, despite having used its best efforts, the requested member of INFOSYS GROUP is not in a position to notify the Competent Supervisory Authority, it must annually provide general information on the requests it received to the Competent Supervisory Authority (e.g. number of applications for disclosure, type of data requested, requester, if possible, etc.).

In any case, the transfers of personal data by a member of the INFOSYS GROUP to any public authority cannot be massive, disproportionate and indiscriminate in a manner that would go beyond what is necessary in a democratic society.

## 2.4 Cooperation with the controller

INFOSYS GROUP and its subprocessors will always cooperate and assist the controller to comply with data protection law, such as its duty to respect the data subject rights or to handle their complaints, or to be in a position to reply to investigation or inquiry from Supervisory Authorities. The cooperation shall be done in a reasonable time, to the extent reasonably possible and consists in

- transmission of data subject's requests to the controller,
- provision of helpful information to the extent available; and
- carrying out necessary measures requested by the controller.

INFOSYS GROUP and its subprocessors will assist the controller by any appropriate technical and organizational measures, taking into account the nature of the processing and to the extent possible, when asked by the controller, for the fulfilment of the controller's obligations to respond to requests for exercising the data subjects' rights including by communicating any useful information in order to help the controller to comply with the duty to respect the rights of the data subjects.

INFOSYS GROUP and its subprocessors will transmit to the controller any data subject request without answering it unless they are authorized to do so.

### **3. Third party beneficiary rights**

The BCR grant rights to data subjects to enforce the rules as third-party beneficiaries directly against INFOSYS GROUP as processor where the requirements at stake are specifically directed to processors in accordance with the GDPR. The data subjects are in particular entitled to enforce the following elements of the BCR:

- Duty to respect the instructions from the controller regarding the data processing including for data transfers to third countries (Section 2);
- Duty to implement appropriate technical and organizational security measures and duty to notify any personal data breach to the controller;
- Duty to respect the conditions when engaging a subprocessor either within or outside the INFOSYS GROUP (Section 2.1);
- Duty to cooperate with and assist the controller in complying and demonstrating compliance with the law such as for answering requests from data subjects in relation to their rights (Section 2.3);
- Easy access to BCR;
- Right to complain through internal complaint mechanisms (Section 4);
- Duty to cooperate with the Competent Supervisory Authority (Section 6);
- Liability, compensation and jurisdiction provisions (Section 5); and
- National legislation preventing respect of BCR (Section 2.2).

The BCR grant data subjects rights to enforce the BCR as third-party beneficiaries in case the data subject is not able to bring a claim against the data controller because the controller has factually disappeared or ceased to exist in law or has become insolvent, unless any successor entity has assumed the entire legal obligations of the data controller by contract or by operation of law, in which case the data subject can enforce its rights against such entity. Such third-party beneficiaries include in particular:

- Duty to respect the BCR (Section 1.1.3);
- The creation of third-party beneficiary rights for data subjects, including the possibility to lodge a complaint before the Competent Supervisory Authorities- and before the courts (Section 3);
- Duty for Infosys Germany Holding GmbH to accept liability for paying compensation and to remedy breaches of the BCR (Section 5), the burden of proof lies with the member of INFOSYS GROUP not the individual (Section 5);
- Easy access to the BCR for data subjects and in particular easy access to information regarding third-party beneficiary rights for data subjects;
- The existence of a complaint handling process for the BCR (Section 4);
- Duty to cooperate with Supervisory Authorities (Section 6);
- Duty to cooperate with the controller (Section 2.3);
- Data protection principles including the rules on transfers or onward transfers outside of the EEA (Section 2);
- Accountability obligation;
- The list of entities bound by the BCR (Section 1.1.1 in connection with Appendix 1); and
- Material scope (Section 1.1.2);
- The need to be transparent where national legislation prevents the group from complying with the BCR (Section 2.2).

If a member of INFOSYS GROUP outside the EEA violates the BCRs, the courts or other competent authorities in the EEA will have jurisdiction and the data subject will have the rights and remedies against Infosys Germany Holding GmbH as if the violation had been caused by it in the Member State in which it is based instead of the member of INFOSYS GROUP outside the EEA.

Where the data subject demonstrates that it suffers any damage and presents facts showing that the damage was probably caused by a breach of the BCR, Infosys Germany Holding GmbH may discharge itself from any responsibility by proving that the INFOSYS GROUP member outside the EEA or the subprocessor is not responsible for the breach of the BCR, which has caused the damage or that such breach did not take place.

The data subjects can choose to lodge complaints:

- In the jurisdiction of the data exporter located in the EEA; or
- In the jurisdiction of the EEA member with delegated responsibilities; or
- Before the Competent Supervisory Authority (choice between the Supervisory Authority in the EEA Member State of his/her habitual residence, place of work or place of the alleged infringement); or
- Before the competent court of the EEA Member States (choice for the data subject to act before the courts where the controller or INFOSYS GROUP has an establishment or where the data subject has his or her habitual residence).

Where INFOSYS GROUP and the controller involved in the same processing are found responsible for any damage caused by such processing, the data subject shall be entitled to receive compensation for the entire damage directly from the INFOSYS GROUP.

The data subjects have the right to judicial remedies and the right to obtain redress and, where appropriate, compensation in case of any breach of one of the enforceable elements of the BCR as enumerated above.

These rights do not extend to those elements of the BCR pertaining to internal mechanisms implemented within entities such as detail of training, audit programmes, compliance network, and mechanism for updating of the rules.

Data subjects shall be informed about their third-party beneficiary rights as well as about the means, how to exercise these rights. Every data subject will be provided with easy access to the BCR. Every member of INFOSYS GROUP is entitled to inform data subjects whose personal data are processed by another member on behalf of such member.

#### **4. Internal complaint mechanisms**

INFOSYS GROUP has put in place a complaint handling process where any data subject may complain that any member of INFOSYS GROUP is not complying with the BCR.

All members of INFOSYS GROUP are obliged to communicate a claim or request without undue delay to the controller without obligation to handle it, except if it has been agreed otherwise with the controller. INFOSYS GROUP is obliged to handle complaints from data subjects where the controller has disappeared factually or has ceased to exist in law or became insolvent.

Data subjects can bring complaints regarding non-compliance of INFOSYS GROUP member with the BCR in writing by contacting the local DPO (if appointed) or the Global DPO (privacy@infosys.com). The local DPO will forward complaints to the Global DPO. Employees of the INFOSYS GROUP may complain that any member of INFOSYS GROUP is not complying with the BCR by using the respective internal ticketing system.

The Global DPO will acknowledge receipt of a complaint, as submitted either by the data subjects concerned directly or as forwarded by the local DPO, to the data subject concerned within ten working days, investigating and making a substantive response within one month. If, due to the complexity of the complaint and number of the requests, a substantive response cannot be given within this period, the Global DPO will advise the complainant accordingly and provide a reasonable estimate for the timescale within which a response will be provided, which shall not exceed three months from the date the complaint was brought. The data subject will be informed on the extension of the response time within 1 month of the receipt of the complaint.

Data subjects whose personal data are collected and/or processed and in accordance with EEA data protection law have the right to complain to a Competent Supervisory Authority and/or to lodge a complaint with a court of competent jurisdiction. This includes where they are not satisfied with the way in which the complaint relating to the BCR has been resolved. Data subjects entitled to such rights will be notified accordingly as part of the complaints handling process. The INFOSYS GROUP member(s) subject to the complaint shall follow-through without undue delay with any remedial action as required to alleviate the complaint, where the Competent Supervisory Authority or a court of competent jurisdiction considers the complaint as justified.

#### **5. Liability**

The controller is entitled to enforce the BCR against any INFOSYS GROUP member for any violation of the BCR caused by that member. The controller is also entitled to enforce BCR against Infosys Germany Holding GmbH due to a breach of the BCR or the data processing agreement by a member of INFOSYS GROUP domiciled outside the EEA or due to a breach of the data processing agreement by an external subprocessor domiciled outside the EEA.

Infosys Germany Holding GmbH accepts responsibility for and agrees (i) to take the necessary action to remedy the acts of other INFOSYS GROUP members or external subprocessors outside of the EEA and (ii) to pay compensation for any material or non-material damages resulting from the breach of the BCR by the INFOSYS GROUP members or external subprocessors.

If a member of INFOSYS GROUP or an external subprocessor outside the EEA violates the BCR, the courts or other competent authorities in the EEA will have jurisdiction and the data subject will have the rights and remedies against Infosys Germany Holding GmbH as if the breach had been caused by them in the EEA Member State in which they are based instead of the member of INFOSYS GROUP or the external subprocessor outside the EEA.

The burden of proof stays with Infosys Germany Holding GmbH to demonstrate that neither the INFOSYS GROUP member outside the EEA nor the subprocessor is liable for the breach resulting in the damages claimed by the data subject.

If the controller can prove that it suffered damage and establish facts which show it is likely that the damage has occurred because of the breach of the BCR, it will be for Infosys Germany Holding GmbH to prove that the INFOSYS GROUP member outside the EEA or the external subprocessor was not responsible for the breach of the BCR giving rise to those damages or that no such breach took place.

If Infosys Germany Holding GmbH can prove that the INFOSYS GROUP member outside the EEA is not liable for the breach, it may discharge itself from any responsibility.

## **6. Mutual assistance and cooperation with Competent Supervisory Authority**

INFOSYS GROUP members accept to cooperate, to be inspected and assist each other to handle a request or complaint from an individual or an investigation or inquiry by the Competent Supervisory Authority and the INFOSYS GROUP members are obliged to cooperate with the Competent Supervisory Authority, to take into account their advice, to abide by their decisions and to accept to be audited by and to be inspected by them including, where necessary, on-site or to accept audits by them.
