





MEMORANDUM OF UNDERSTANDING

M/s. Medicare Environmental management Pvt. Ltd., having its registered office at No. 6-3-1089/G/16, 1st Floor, Gulmohar Avenue, Rajbhavan Road, Somajiguda, Hyderabad - 500082, and having branch office at No. 25 - 30, 2nd Cross, Raghavendra Nagar, Hennur Ring Road, Kalyan Nagar (post), Bangalore - 560043, hereinafter referred to as M/s Medicare Environmental Management Pvt. Ltd. Represented by it's Authorized Signatory and M/s. Infosys Limited having its office at, IL Milestones SEZ unit, BCIT, Bharatiya city, Block 1, Thanisandra Main Road, Chokkanahalli Bangalore - 560064.

referred as M/s. Infosys Limited is hereby agreed and come to the Memorandum of Understanding on this 01 / 01 / 2019 as detailed below:

- a. M/s. Medicare Environmental Management Pvt. Ltd. with consent from Karnataka State Pollution Control Board is having a common treatment facility for Managing Bio-Medical Waste in Bangalore rural district at Dabaspet 40 Km on NH4. The facility is having a state of art Auto clave system along with the shredder and Incinerator.
- b. M/s. Infosys Limited gives its bio-medical waste, properly packed in color-coded bags as per pollution control Board regulations for treatment and final disposal to M/s. Medicare Environmental Management Pvt. Ltd. The waste should be given at one single point by the M/s. Infosys Limited at given time of M/s. Medicare Environmental Management Pvt. Ltd. Vehicle.
- c. M/s. Medicare Environmental Management Pvt. Ltd. will charge a price of RS. 5000/- per month exclusive of all applicable taxes amended from time to time (Up to 100 Kgs per month, if it exceeds ₹ 55/- per Kg will be charged extra) as agreed for collection, transportation, treatment and final disposal of biomedical waste. This price will be fixed for a period of one (1) year from date of this agreement and thereafter there will be 10% (Ten Percent) escalations in the price for every one-year on existing rate.
- d. M/s. Infosys Limited during these Five (5) years, they will not enter into any agreement with any other party or organization for the Bio- Medical waste treatment and disposal.
- e. M/s. Infosys Limited is assuring that payment should be made through Account Payee cheque In favour of M/s. Medicare Environmental Management Pvt. Ltd. on or before 5th of every month.
- f. M/s. Medicare Environmental Management Pvt. Ltd. is not responsible for any cash payments and also we will collect cheque bounce charges.
- g. In case of non-receipt of payment on the agreed date from M/s. Infosys Limited, M/s. Medicare Environmental Management Pvt. Ltd. will stop the collection of waste immediately with intimation to Karnataka State Pollution Control Board. The delayed payments will be collected with an interest of 18% per annum.
- h. M/s. Medicare Environmental Management Pvt. Ltd. will collect medical waste as per your declaration in the application form regularly and treat the waste as per the regulations. M/s. Medicare Environmental Management Pvt. Ltd. will not collect any waste that is not segregated or not properly packed. M/s. Medicare Environmental Management Pvt. Ltd. will not collect general garbage.

- i. M/s. Medicare Environmental Management Pvt. Ltd. will issue a proof of waste collection to M/s. Infosys Limited. This will help the individual institution for getting compliance with the State Pollution Board. The individual institution home can take their Authorization from the pollution control board by informing the board that M/s. Medicare Environmental Management Pvt. Ltd. treats their waste (The same has to be mentioned in the Authorization Form).
- j. In case any institutions find any irregularities in collection of waste, they can send a notice in writing to M/s. Medicare Environmental Management Pvt. Ltd. for immediate action.
- k. M/s Medicare Environmental Management Pvt. Ltd. will maintain their plant in good running condition all the time and ensure continuity of service as per your declaration in application form.
- 1. This Memorandum of understanding is entered into on the express understanding that M/s Medicare Environmental Management Pvt. Ltd. will maintain and run the facilities and collect transport and treat the waste at their plant strictly in accordance with the consent of the Karnataka State Pollution Control Board and it shall be the responsibility to obtain the consent and keep the same always current.
- m. In case of violation of any of the agreed condition of the MOU by either side. Issue of notice may terminate this MOU three months in advance by either party for terminating their respective obligations.

Legal Clause:

- a. The occupier and the operator of the facility shall liable to pay financial penalties as levied for any violation of the provisions under the rules BIO MEDICAL WASTE DISPOSAL by the state pollution control board. This Clause will apply only for the bio medical waste handed over to M/s Medicare Environmental Management Pvt. Ltd. by M/s INFOSYS LIMITED with proper document.
- b. The occupier, transporter and the operator of the facility shall be liable for all the damages caused to the environment or third patty due to improper handling/transportation, disposal of the biomedical waste and pay financial penalties levied by the company for its storage and disposal to alternative vendor in case of violation of any laws or deliberate disposal. This is applicable only for the bio medical waste collected from M/s INFOSYS LIMITED by M/s Medicare Environmental Management Pvt. Ltd. with proper documentation.
- c. This Memorandum of understanding is entered into on the express of understanding that M/s Medicare Environmental Management Pvt. Ltd. will maintain and run the facilities and collect, transport and treat the waste at their plant strictly in accordance with the consent of the Karnataka State Pollution Control Board and it shall be the responsibility to obtain/renew the consent and keep the same always current.

- d. Infosys or its authorized agent shall have the right to perform an environmental and safety audit with prior approval of service provider at treatment site which Agency is providing Services for the purpose of verifying environmental and safety procedures followed by Agency. If Infosys or its authorized agent (Third party is not allowed in behalf of occupier) is not satisfied with such environmental and safety procedures as per Bio Medical Waste Handling Rules, it shall communicate the same to agency immediately. Agency shall thereupon take all steps to ensure safe, healthy and non-hazardous working environment to the satisfaction of Infosys as per BMW Rules within ten (IO) working days. of receiving such communication, failing which Infosys shall have to terminate this Agreement with immediate effect.
- e. All disputes to this understanding are subjected to the Jurisdiction of the court in Bangalore only.
- f. This Agreement is effective from 01.01.2019 to 31.12.2023 (Five Years).
