This has reference to your letter no. IL/BBSRSEZ/SEIAA/2017-18 dated 13.04.2017 on the above mentioned subject, I am to say that the State Environment Impact Assessment Authority, Odisha have considered the extension of validity of Environmental Clearance for the above project in its meeting held on dated 26.04.2017.

M/s Infosys Limited, as a Co-developer to Odisha Industrial Infrastructure Development Corporation (IDCO) has proposed construction of IT SEZ with Integrated Township "Infovalley" project in Jatani Tahasil of Khordha district. IDCO had obtained Environment Clearance from SEIAA, Odisha vide letter no. SEIAA/292 dated 02.08.2010 which was valid for 5 years for total built up area of 20,81,029 Sqm. The Environmental Clearance was transferred to M/s Infosys Limited (Co-developer) vide SEIAA, Odisha letter no. 188/SEIAA dated 25.09.2012.


